The hard decision has been made to increase both our annual registration fees and gup grading fees, the actual increases will be conveyed to instructors over the next few weeks, in time for implementation in 2010

Also over the next few weeks the Board will be issuing a discussion document calling for submissions on the proposed Strategic Plan, this will be followed in the New Year with one on the proposed structure.

The AGM date has been set for Sunday 18 April 2010
