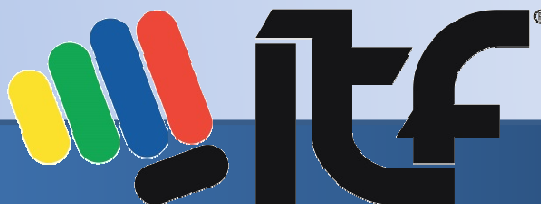

XXVII ITF CONGRESS

Over two months has already passed since the Election of the new ITF Board of Directors during the XXVII ITF Congress, held on 28th April 2019 in Inzell, Germany. It was a very active time for the new officers of ITF in order to start the implementation of the goals and aims mentioned during the election campaign.

Already on 29th April 2019 in Inzell took place the first meeting, which determined the initial working regulations and the short roadmap of activity. The subject discussed there were: amendments of the ITF Constitution and By-Laws, cooperation with the legal adviser, governance practise and introducing of Robert Rules, administrative matters, adjustment of sponsorship agreements, standing committees, membership matters and the update of statuses of our members, global growth and strategy for development of ITF, cooperation with international sport organizations, cooperation with the former Board members.

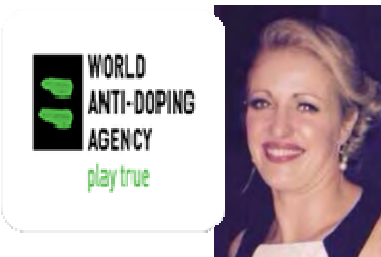
Our actions are now concentrated on the registration of the new board in the court in Spain. Unfortunately the registration is a long process and according to Mr. Manuel Dopico, legal adviser of ITF it may take event three month or longer.

The next ITF Board of Directors meeting will take place from 4th to 8th September 2019 in Frankfurt, Germany.



The SPORT ACCORD Convention 2019 took place from 05th to 10th May in Gold Coast, Australia. ITF was represented by the delegation consisted of Master Tadeusz Loboda – ITF Secretary General and Master Lazaros Tsilfidis – ITF Vice-President Member. Our main goal is to become a member of GAISF. During many meetings, amongs them one with the President of World Taekwondo doctor Chungwon Choue and WT Senior Director Mr Jeonghang Se, our representation had chance to establish many contacts and bring ITF closer to this goal. Also they had chance to introduce taekwon-do and its benefits during lectures. Our delegation was also present during election of new GAISF and Sport Accord's President Mr. Raffaele Chiulli, who is also President of UIM (International Powerboating Federation) and President of ARISF (Association of IOC Recognised International Sports Federations).

IMPORTANT NOTES TO OUR MEMBERS

1. Replacement Certificates

For special reasons we would like to remind all members of the **correct procedure** for applying for replacement certificates:

- the ITF office need a (scanned) copy of the original certificates (e.g. Choi Jung Hwa group or Ri Yong Song group). Any other group needs the permission of the ITF Board of Directors. Example: a 3rd degree from Choi Jung Hwa group have to apply for the 1st, 2nd and 3rd degree certificate with the scanned copy of his original certificates. Candidates from 4th degree and higher needs at least one IIC course to be recognized.
- the ITF offer a reduced price for replacement certificates (please compare our fee table)
- **national certificates are not replacement certificates!** These candidates have to pay the full price according our fee table.

2. ITF Constitution

The ITF Constitution and By-Laws are to be revised. If the Associations have very important suggestions, please send them until **July 31st = deadline!**

3. Publication of ITF activities on Facebook, Twitter, Instagram

We would like to remind you that official ITF activities have to be published on the ITF website first and **after** that on other social media and not vice versa. Please follow this procedure!

Private activities cannot be published on the ITF website!
