For several days productive meetings and discussions regarding future projects for the ITF took place. During the meeting many issues were raised. Our Board of Directors worked very hard for these five days to make our ITF better for our members.



The ITF Harmony program has been presented at the XVI Congress of Gerontology and Geriatrics held from 22nd - 24th August 2019 in Mar del Plata Argentina.
